**VAPING** – Vaping is not permitted on school property. This includes both inside and outside the school. **Signs have been posted.** 

The Tobacco and Vaping Products Act (TVPA) was enacted on May 23, 2018 to regulate the promotion, sale and use of tobacco and vaping products in Canada.

A Toronto Public Health Inspector visited Birchmount Park CI prior to March Break to discuss the health concerns connected to Vaping. The inspector stressed:

- Vape products contain nicotine and are addictive substances.
- Smoking and Vaping on school property is subject to fines of \$305.00.

Birchmount Park CI has experienced an increase in the number of students Vaping on school property. We ask for your assistance in reviewing the legal as well as the health issues related to Vaping.

The administration will be taking progressive steps to address both smoking and vaping on school property.

# CELLPHONES & PEDs IN THE CLASSROOM

Powering down in the classroom!
Reminders to BPCI Students, Parents
& Guardians that the private use of
cellphones and Personal Electronic
Devices in the classroom interrupts and
distracts students from learning.

School Expectations are outlined in the School Code of Conduct on page 16 of the Student Agenda.

#### Reminders for students:

- The use of Cellphones and PEDs should never interfere with the learning environment of the classroom.
- The use of Cellphones and PEDs will not be permitted in the classroom unless the teacher approves their use for educational purposes only.
- Students with IEP's will continue to have access to assistive technology as stated in their IEP's.
- Students are to ensure that Cellphones and PEDs are powered down or on silent mode and out of sight in classrooms and other teaching spaces in the school.
- Privacy laws prohibit the filming, recording and/or taking of pictures on school property without the written permission of the staff member and/or student.
- The use of a Cellphone or PED to photograph, film or record a conflict, argument or fight between individuals is not acceptable as it aids and incites harmful behaviour in the BPCI school community.

BPCI will be reviewing the School Cellphone / PED policy for the 2019-2020 school year.
