Dear Parents and Guardians,

I just wanted to take a moment to connect with our Derrydown School community and firstly acknowledge that this is a difficult and unprecedented time and situation for our generation and that we your child's teacher(s) and support staff continue to think about and seek ways to support the well-being of all students, their families and each other.

I wanted to share a few reminders, as I realize that information is coming very quickly and constantly and rapidly changes from day to day.

First, what we know from the Ontario government that schools <u>WILL NOT</u> re-open on April 6th. When we have more information on new timelines, we will share that with you.

Here is the link to the Ministry of Education's <u>Learn at Home</u> website. This portal provides supplementary learning materials in math and literacy for elementary and secondary students. The website will help keep students learning and engaged during the COVID-19 school closure period. The Ministry has said that these resources do not replace what students have been learning at school, but are intended to help mitigate the loss of learning during the COVID-19 shutdown period.

Here is a second link to the <u>TDSB Student Learning Resources</u> that will support the Ministry's Learn at Home initiative.

Going forward student well-being and mental health will also be an important focus. Both school-based staff and Professional Support Services share responsibilities for supporting student well-being. There are a variety of <a href="Mental Health and Well-Being Resources">Mental Health and Well-Being Resources</a> for students and families available on the TDSB web.

This week and next are being used to set up our system for success. We are gathering information, assessing needs, and formulating plans about the continuation of learning and will be communicating with our school community and families as soon as these plans are finalized. Some of you may have received a call from Mrs. Romanovich or me inquiring as to your child's access to technology at home as well as a current email address that the school and school board can contact you as needed. Having an up-to-date email address and contact phone numbers is essential at this time as we will be using our automated system *School Messenger* to share information and updates. I will keep the community informed in an on-going way as we continue this work moving forward.
