School Council By-law Review</p>	<p>Regulation 612/00 15 (1-3) of the Education Act indicates that every School Council shall make the following By-Laws:</p> <ul style="list-style-type: none"> ● By-Laws that govern election procedures and the filling of vacancies in the membership of the School Council; ● By-Laws that establish rules respecting participation in School Council proceedings in cases of conflict of interest; ● By-Laws that establish a conflict resolution process for School Council disputes. <p>To support this process, TDSB has updated the School Council By-Laws' Template. The update includes:</p> <ul style="list-style-type: none"> ● Mandatory articles that must be inserted into all TDSB School Council By-Laws; ● Optional articles that School Councils may or may not choose to insert; ● A template system that will enable School Councils to input their information and to have the By-Laws returned within 5 – 7 business days. 	<ul style="list-style-type: none"> - TDSB's School Council By-Laws' Template. - Link to be emailed to Co-Chairs to complete <p>By-Laws' Review Process</p> <ul style="list-style-type: none"> ● Consultation - School Council Chair prints pdf, then shares & consults with School Council and parents/caregivers for input; ● School Council Approval - School Council reviews the template and votes on the option articles; ● A Word and pdf version of the School Council's submission is sent to the submitter, the Principal, the CSW (if applicable) and PCEO; ● School Council distribute a copy to all School Council members and stores a copy at the school in an accessible format and posts on the school website, if possible.
