**PARENT/GUARDIAN AND STUDENT ACKNOWLEDGEMENT OF THE TERMS AND  
CONDITIONS OF THE HPP**

**Instructions:** Please read the below terms carefully and contact the school with any questions.

1. We understand that completing and signing this Information and Application for Admission form and agreeing to the below terms are a prerequisite for the student's enrollment in the HPP.
2. We are aware that the TDSB will conduct an entrance application assessment of the student prior to the student's acceptance and placement in the HPP and a review of the student's training program.
3. The parent/guardian and the HPP student shall work closely with the Principal, school staff and teachers at their school in making plans for the submission of assignments, the writing of tests, meeting deadlines, and other requirements.
4. All HPP students are expected to complete all course work for all subject areas as outlined by the Ministry of Education.
5. Time for independent in class work to complete assignments and or course work may be reduced due to student training schedules.
6. The parent/guardian and HPP student shall maintain effective communication with school staff. HPP students must inform administrators of any change to the training schedule as soon as they become aware of the change.
7. The parent/guardian and the HPP student shall keep the TDSB informed of any behavioural, health and/or safety issues that might impact the student's performance. Further, the parent/guardian will immediately inform the TDSB of a concussion and follow the TDSB's and club's/team's concussion policy and procedures.

8. The parent/guardian and the training facilities/club/team are responsible for organizing all national/international travel accommodations, inclusive of tickets, cancellation insurance, and health insurance for the HPP student, as required.
9. The parent/guardian is responsible for health and medical expenses as well as insurance coverage. The parent/guardian may purchase student accident insurance by visiting [www.insuremykids.com](http://www.insuremykids.com).
10. The parent/guardian or the training facilities shall assume responsibility for the safety and supervision of the HPP student during competitions, training or performances, including travel to and from a facility.
11. This HPP is provided to support student athletes. It is expected that HPP students will take responsibility for working diligently to balance their academics and athletics. Any behaviour which compromises their good standing in the program may result in removal from the HPP.
