



• THIS “NO STOPPING, 8 AM - 4 PM, MON - FRI” SIGN MEANS DURING THE HOURS OF 8 A.M. TO 4 P.M., MONDAY TO FRIDAY, YOU MAY NOT STOP FOR ANY REASON BEYOND AVOIDING A COLLISION OR TO COMPLY WITH POLICE INSTRUCTIONS

• YOU MAY NOT STOP, NO MATTER HOW BRIEFLY, TO DROP OFF/PICK UP PASSENGERS

• THE REASON FOR THIS REGULATION IS TO MAINTAIN CLEAR SIGHTLINES FOR PEDESTRIANS AND MOTORISTS

THE FINE FOR DISOBEYING THIS REGULATION IS: \$60



• THIS “NO PARKING ANYTIME” SIGN MEANS

PARKING IS PROHIBITED AT ANYTIME, YOU MAY NOT PARK FOR ANY REASON OTHER THAN TO QUICKLY DROP OFF/PICK UP PASSENGERS AND IMMEDIATELY LEAVE. THE DRIVER MUST NOT EXIT THEIR VEHICLE WHEN DROPPING OFF/PICKING UP THEIR PASSENGERS

• THE REASON FOR THIS PROHIBITION IS TO PREVENT TRAFFIC CONGESTION AND TO MAINTAIN CLEAR SIGHTLINES FOR PEDESTRIANS AND MOTORISTS

THE FINE FOR DISOBEYING THIS REGULATION IS: \$40

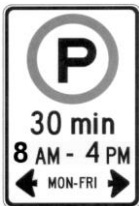


• THIS “NO PARKING, 8 AM - 4 PM, MON - FRI” SIGN MEANS

DURING THE HOURS OF 8 A.M. TO 4 P.M., MONDAY TO FRIDAY, YOU MAY NOT PARK FOR ANY REASON OTHER THAN TO QUICKLY DROP OFF/PICK UP PASSENGERS AND IMMEDIATELY LEAVE. THE DRIVER MUST NOT EXIT THEIR VEHICLE WHEN DROPPING OFF/PICKING UP THEIR PASSENGERS

• THE REASON FOR THIS REGULATION IS TO PROVIDE AN AREA, SIMILAR TO A KISS AND RIDE, FOR PARENTS TO QUICKLY DROP OFF/PICK UP THEIR CHILDREN AND LEAVE. THIS PREVENTS TRAFFIC CONGESTION.

THE FINE FOR DISOBEYING THIS REGULATION IS: \$40

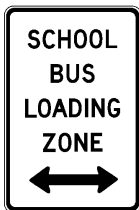


• THIS “30 MINUTE, 8 AM - 4 PM, MON - FRI” SIGN MEANS

DURING THE HOURS OF 8 A.M. TO 4 P.M., MONDAY TO FRIDAY, WITHIN THE ARROWS OF THESE SIGNS, YOU ARE PERMITTED TO PARK FOR A MAXIMUM OF 30 MINUTES

• THE REASON FOR THIS REGULATION IS TO ALLOW TEMPORARY PARKING NEXT TO THE SCHOOL AND AVOID PEDESTRIAN AND VEHICLE CONFLICTS

THE FINE FOR EXCEEDING THE 30 MINUTE TIME LIMIT IS: \$40



• THIS “SCHOOL BUS LOADING ZONE” SIGN MEANS

UNLESS YOUR VEHICLE IS A SCHOOL BUS (AS DEFINED IN THE HIGHWAY TRAFFIC ACT), YOU MAY NOT PARK WITHIN THE DEFINED LIMITS AT ANY TIME

• YOU MAY NOT STOP, NO MATTER HOW BRIEFLY, TO DROP OFF/PICK UP YOUR OWN PASSENGERS

• THE REASON FOR THIS REGULATION IS TO ALLOW EXCLUSIVE SCHOOL BUS ACCESS TO SPECIFIC SCHOOL CURB SIDE AREAS AND AVOID EXCESSIVE USE OF BUS FLASHERS

THE FINE FOR DISOBEYING THIS REGULATION IS: \$60

NO PERSON SHALL ON ANY HIGHWAY (ROAD) PARK ANY VEHICLE:

• IN FRONT OF OR WITHIN 60.0 CENTIMETRES OF A DRIVEWAY OR LANEWAY OR SO AS TO OBSTRUCT VEHICLES IN THE USE OF A DRIVEWAY OR LANEWAY **THE FINE FOR DISOBEYING IS \$40**

• WITHIN THREE METRES ADJACENT TO ANY FIRE HYDRANT **THE FINE FOR DISOBEYING IS \$100**

• FOR A PERIOD LONGER THAN THREE HOURS **THE FINE FOR DISOBEYING IS \$15**

• IN SUCH POSITION AS WILL PREVENT THE REMOVAL OF ANY OTHER VEHICLE PREVIOUSLY PARKED **THE FINE FOR DISOBEYING IS \$40**
