1-Welcome and Introduction Debbie Levy,

4- Administration Report

 Gerri Gershon introduced and welcomed our new principal Mrs Kwon. Mrs Kwon gave a brief summary of her previous experience as principal at Sunnyview PS (JK-Grade 8). Sunnyview is a school for student with physical and mental disability. She mentioned the warm welcome that she has received from the kids and families at Owen and her appreciation and gratitude for everyone for a smooth transition.

- Mrs Kwon announced that this year enrolment is 632.
- She mentioned that overall transition to full day Kindergarten has been very smooth so far. The main challenge is the space available specially at lunch time. She announced that she has ordered several new lunch tables (cost 11000) which should arrive over the next few weeks. The other big challenge is the rainy days and indoor playing. She mentioned that each class will have bins of games to play inside and there will be movies on smart boards. She called all parents for donations of board games for these occasions.
- The VP Mikki Hymus welcomed all new staffs to Owen. She said that most teachers have now their website up and running. She also explained that due to the new rules of privacy established by TDSB (CASL) we can not send anymore publicity etc via email. She encouraged all parents to sign and send back the authorisation forms in order to receive Owen Online via email.
- With the new full day Kindergarten, there are now new classes open and the school requires possibly 4 more smart boards.
- Fundraising Plans:
 - **Pizza Lunch: Kristi & Annette have now taken over** pizza lunch program this year. The pizza forms were sent out. First rounds will start in Oct.
 - Dance-a-thon Caroline Thompson takes over from Elizabeth & Chanh it will be in Feb 9th
 - **Spring Fling: Debbie** we are looking for someone who can take over the leadership on this. Also Sarah will not run the games next year. Please contact Debbie if you are interested.
 - **Fall Affaire:** Cecilia who is no longer at our school has explained the event. This fundraising event is an adult only evening on Nov the 6th. This year the event will be held in the Vaughn Room at the Sunnybruck Estates.
 - Subway lunch will be replacing Quiznos lunch this year

7- Committees

There was a long discussion regarding the limited space for the Kindergarden classes. Mikki reassured that she has checked all the registrations to make sure that all the kids are within the Owen catchment area. There was also a lengthy discussion whether daycare should stay within school facilities or move out of the building. Mikki reminded everyone that Daycare currently subsidizes families who have no access to aftercare. It was felt overall that moving the Daycare won't be the best option and will create further problems.
