Preschool .	\$55.00	2.5 years - 4 years (30 to 48 months)
Kindergarten - Third Party Before & After School	\$35.00	Age 4 & 5 - Instructional Days
Kindergarten - Third Party After School	\$25.00	Age 4 & 5 - Instructional Days
Kindergarten - Third Party Full Day	\$48.00*	Age 4 & 5 – Summer, PA Days, Christmas, & March Break
Kindergarten – Escorted Before & After School	\$35.00	Age 4 & 5 - Instructional Days Care is offered outside the Kindergarten classroom
School Age - Before, Lunch & After School (12M Pr.)	\$45.00	Grade 1 to 6 - Instructional Days (includes lunch)
School Age - Full Day	\$45.00*	Grade 1 to 6 - Summer, PA Days, Christmas & March Break
School Age - Before & After School	\$30.00	Grade 1 to 6 - Instructional Days Only
School Age - After School	\$20.00	Grade 1 to 6 - Instructional Days Only

#### **VACATION DAY AND SICK DAY POLICY:**

Since child care costs are consistent all year and the level of fees is based on 52 weeks per year, we require parents to pay for their space in the child care centre even when they are on vacation, sick and for statutory holidays.

### NO NOTICE WITHDRAWAL POLICY:

Parents are required to give two (2) weeks notice prior to withdrawal. If no notice is given, a ten (10) day charge will apply at the full rate.

#### **NSF POLICY:**

- A fourteen dollar (\$14.00) penalty will be applied for cheques that are returned NSF.
- After the second NSF cheque, all cheques on hand will be returned. No future cheques will be accepted.
- Payment type will be money order or certified cheque only.

# FEE PAYMENT POLICY

- All fees are due in advance
- Weekly fees are due every Monday
- Monthly fees are due on the first (1st) business day of the month
- A 5% penalty will be applied to all past due balances
- Failure to pay fees will result in withdrawal of your child/ren from care

#### **DEPOSIT POLICY:**

The first 2 weeks fees are due on the child/ren start date.
